Here's how it works.

1. Fill a prescription for an eligible insulin or other certain diabetic medications.
2. Pay no more than \$25 for a 30-day supply (or no more than \$75 for a 90-day supply) of insulin and some non-insulin medications.¹ Note your deductible doesn't apply to these medications.

Insulins: Basaglar[®], Humalog[®] (except vials), Humalog[®] Mix, Humulin[®]

Non-Insulins: Farxiga[®], Jardiance[®], Jentadueto[®], Jentadueto[®] XR, Mounjaro[®], Ozempic[®], Rybelsus[®], Synjardy[®], Synjardy[®] XR, Tradjenta[®], Trulicity[®], Xigduo[®] XR

If you're not taking a medication on this list, you can call your doctor's office and ask if one of these medications will work for you. If your doctor agrees, ask the office to send a new prescription electronically to your pharmacy.
